#### 1.0 **INTRODUCTION**

#### 2.0 INSTRUCTIONS TO BIDDERS

- 2.1 The tender shall be submitted in two sealed envelopes:
  - Part I : Technical Bid Proposal in sealed envelope
  - Part II : Financial Bid Proposal in sealed envelope

#### PART - I -SEALED TECHNICAL BID IN ENVELOPE NO.1:

- a) National Horticultural Research and Development Foundation, payable at New Delhi must be deposited. The amount of EMD and Tender fee will be acceptable only by way of demand draft. Amount deposited by any other mode will not be acceptable. Any technical bid not accompanied with amount of EMD and Tender Fee through prescribed mode of payment, is liable to be summarily rejected.
- b) The tenderer should submit self-attested certificate of incorporation of the firm/company, memorandum and articles of association.
- c) Name of the bidder, address, contact numbers (office and mobile number), email address, nature of firm/company (proprietorship/partnership firm/private or public limited company, name of the Chief Executive etc. may be furnished.

#### PART -II - SEALED FINANCIAL BID IN ENVELOPE NO. 2:

- a) National Horticultural Research and Development Foundation, payable at New Delhi must be deposited. The amount of EMD and Tender fee will be acceptable only by way of demand draft. Amount deposited by any other mode will not be acceptable. Any technical bid not accompanied with amount of EMD and Tender Fee through prescribed mode of payment, is liable to be summarily rejected.
- b) The amount of EMD of unsuccessful tenderers shall be returned within a 30 days' period of time without payment of any interest.
- c) In case of successful tenderer, the amount of EMD will be retained by NHRDF and shall be adjusted against the security deposit which will be 5% of the total value of the project cost.
- d) The tenderers should submit rates against each item along with break-up as per BOQ in the financial bid. The financial bid should be submitted without any condition.
- e) The tenderers are advised to undertake at their discretion a reconaissance of the site to familiarize themselves with the site conditions before preparing the bid documents at their own cost.
- f) The two sealed envelopes of Technical and Financial Bids should be put in another sealed master envelope super-scribing tender "supply of DGCA approved agriculture drone 10 kg payload at Krishi Vigyan Kendra.

#### The tender should reach

a) National Horticultural Research and Development Foundation, Ujwa, New Delhi by 10/11/2022 latest upto 2.30 PM. We shall not be responsible for any delay in receipt of the tender. Late tenders shall not be considered. The Director NHRDF reserves the right to reject any or all the tenders, without assigning any reasons thereof.

#### 3.0 GENERAL TERMS AND CONDITIONS

- 1. Kisan drone should be DGCA approved and registered at Digital Sky portal under appropriate category.
- 2. The drone should have all safety features i.e. sensor based collision avoidance, terrain following, first person view camera, auto return to launch point etc.
- 3. The manufacture should have proper setup and infrastructure for drone manufacturing in India.
- 4. Type approval certificate of quality council of India or authorized testing entities shall be necessary.
- 5. Manufacture must have service support in the concerned state to provide after sale support, training, repair and maintenance etc. to the customers.
- 6. The manufacture should have all service support on pilot training.
- 7. The supplier shall provide the complete demonstration of working of the Agri. Drone.
- 8. Boarding and Lodging arrangement: The tenderers shall make their own arrangement for boarding, lodging, travel, transportation of equipment, vehicle, labourers, local transport etc. required for supply of Drone.
- 9. Time period for Supply The supply of DGCA Approved Agriculture Drone 10 Kg Payload should be completed in all respect within 10 days from date of supply order.
- 10. Liquidated damages: Time is the essence of the contract. Liquidated damages shall be imposed @ 0.5% of the tender amount for each week of delay subject to a maximum of 5% of total agreed cost.
- 11. Signing of Agreement: The successful tenderer shall be required to sign an agreement on non-judicial stamp paper of Rs. 100/- before commencement of the supply.
- 12. Incomplete/late submission of tender: Incomplete tender or tender received after the prescribed last date and time shall not be considered under any circumstances.

13. Financial / Payment Conditions:

No request for the advance will be entertained by the NHRDF. Payment will be made after successful supply and demo of drone.

- 14. Dispute: In the event of any dispute, the effort will be first made to amicably resolve the dispute. In case the dispute still remains unresolved, the same shall be referred to the sole arbitration of the Director, NHRDF, New Delhi and his decision shall be final & binding on both the parties to the agreement. The arbitration proceedings shall be held in accordance with Indian Arbitration Act. The venue of the arbitration shall be at New Delhi.
- 15. Acceptance/Rejection of tender: Director NHRDF, New Delhi. reserves the right to reject any one or all the tenders without assigning any reason thereof.
- 16. Submission of Final bill: The final bill should be submitted within a week of satisfactory delivered of the supply of agri. drone.
- 17. EMD 1% + 4% i.e. 5% will be retained with NHRDF for defect liability period of 2 years from the date of handing over the drone to NHRDF.

#### 4. SPECIAL CONDITIONS OF CONTRACT:

- 4.1 The tenderer shall nominate and authorize one of its officers for liaising with KVK/NHRDF personnel in connection with the supply of drone.
- 4.2 The tenderers shall be solely responsible for the safety, loss, theft, break down etc. of their equipment and safety of the manpower and shall get the same appropriately insured.
- 4.3 Only brief specifications have been given in the BOQ. However, all the works shall be executed as per relevant codes of practice as may be applicable. The bidder shall include the procedure in their methodology and shall execute works as approved Director NHRDF at KVK, Ujwa.
- 4.4 All rates quoted shall be inclusive of all duties, taxes, octroi etc. as may be applicable. GST shall be paid as applicable on production of documentary proof. No extra claim shall be payable. Director NHRDF. shall however deduct taxes at source, as may be applicable and shall provide a certificate in lieu thereof.

#### 5.0 SCOPE OF Agri Drone:

The tenderer shall carry out and supply the agri drone in every respect in accordance with this contract and with the directions of and to the satisfaction of the Client. The client may in absolute discretion and from time to time issue written instructions, details, directions and explanations which are hereafter collectively

referred to as" instructions" reflected either in the minutes or in any other form in regard to:

- a. Manufacture must have service support in the concerned state to provide after sale support, training, repair and maintenance etc. to the customers.
- b. The supplier shall provide the complete demonstration of working of the Agri. Drone.
- c. Supplier of drone should impart training to KVK staff for handling of drone time to time.
- 6.0 **Validity of Tender**: Tender will be valid for a period of 1 months from the date of submission.

The Director, shall have a right to delete any item of work from the scope of contract and Contractor shall not make any extra claim on this account.
